

## Terms and Conditions for Summer Cash Splash Bonus Draws - Draw 1154

### 1.0 General

- 1.1 These terms and conditions for the in **Draw 1154** form part of the General Terms and Conditions for yourtown Prize Home Draw 1154 Terms and Conditions <https://yourtownprizehomes.com.au/terms-and-conditions> and myplace Terms Conditions <https://yourtownprizehomes.com.au/terms-and-conditions/myplace-membership>. Entry into these draws detailed in these terms and conditions is deemed acceptance of these Terms and Conditions and entrants warrant that they are not prohibited from accepting a prize.
- 1.2 The **Summer Cash Splash Bonus Draws** are licenced under the following permit numbers Qld 29586, NSW GOCAU/2322, VIC 10446/25, SA M14891 and ACT TP25/00217.
- 1.3 These Art Unions are run by **yourtown** ABN 11 102 379 386 of 5 Cordova Street, Milton Qld 4064.
- 1.4 The **Summer Cash Splash Bonus Draws** will be drawn by electronic draw at 6am AEST at **yourtown**, 5 Cordova Street, Milton Qld 4064 on the stipulated dates listed in Section 2.1.2 of these Terms and Conditions.
- 1.5 Winner will be announced on the day of the draw and published on the **yourtown** website at <https://yourtownprizehomes.com.au/winners>. Winners will be notified via phone and in writing by email or post (where applicable and details are on file).
- 1.6 Unclaimed Prizes in ACT and NSW - If a prize is unclaimed in the ACT and NSW within 3 months of the draw date, **yourtown** will comply with the terms and conditions stipulated by ACT Gaming and Racing Commission and NSW Fair Trading in relation to a redraw. Such redraw for **yourtown** Draw 1154 would occur at **yourtown**, Suite 5, Cordova St, Milton Qld 4064 on Friday, 15 May 2026 commencing at **6:00am AEST**. Note: "ACT" refers to the ACT address listed on the ticket of the ticket holder.

Unclaimed prizes will be dealt in accordance with the combined legislative requirements for the conduct of the Draw. In the event that 1<sup>st</sup> Prize remains unclaimed for one year following the date of Draw 1154 a redraw will be conducted on Friday, 19 February 2027 (AEST) at 12.00pm AEST at yourtown Head Office, 5 Cordova Street Milton Qld 4064 by barrel draw. In the event that any bonus draws above \$5,000 in value or member draws above \$5,000 in value remain unclaimed for one year following their draw dates, these will be redrawn on Friday, 19 February 2027 at 6.00am AEST by electronic draw at yourtown Head Office, 5 Cordova Street Milton Qld 4064. Any prizes won by Entrants excluding NSW and ACT residents under \$5,000 in value that have not been claimed within twelve months of the listed Draw Date will be sold and the proceeds applied to **yourtown's** charity purposes.

- 1.8 Entries are open to Australian residents who are 18 years of age or older, but excludes Members of the **yourtown** Board of Directors, Executive Management, any persons engaged in the draw process, all **yourtown** Information and Technology staff, and the immediate family of those detailed, are not eligible to enter. Overseas non-Australian citizens or residents must check in their own country that there are no restrictions on them purchasing a ticket in the draw or accepting the prizes offered as part of the lottery.
- 1.9 Where a prize is or includes gold bullion, Gold is valued at the purchase price on the day of the draw. Selling costs of between 2 and 2.5% apply and are incurred by the winner at the time of sale. The value of the Gold Bullion could be affected by the fluctuating spot price on the day of sale. There are some restrictions to certain states being able to claim a "cash prize" and an alternative prize will be listed if applicable.
- 1.11 Prize values refer to Australian currency. All non-cash prizes are not redeemable for cash and no prize is transferable.

#### 2.1 Summer Cash Splash Bonus Draws
