

# Terms and Conditions for 10 Days of Christmas Bonus Draws Draw 542

### 1.0 General

- 1.7 Unclaimed Prizes in ACT/NSW If a prize is unclaimed in the ACT or NSW within 3 months of the draw date, **yourtown** will comply with the terms and conditions stipulated by ACT Gaming and Racing Commission in relation to a redraw. # Terms and Conditions for 10 Days of Christmas Bonus Draws Draw 542

- 1.9 Entries are open to Australian residents who are 18 years of age or older, but excludes Members of the yourtown Board of Directors, Executive Management, any persons engaged in the draw process, all yourtown Information and Technology staff, and the immediate family of those detailed, are not eligible to enter. Overseas non-Australian citizens or residents must check in their own country that there are no restrictions on them purchasing a ticket in the draw or accepting the prizes offered as part of the lottery.
- 1.10 Where a prize is or includes Gold Bullion, Gold is valued at the purchase price on the day of the draw. Selling costs of between 2 and 2.5% apply and are incurred by the winner at the time of sale. The value of the Gold Bullion could be affected by the fluctuating spot price on the day of sale.
