

1.0 General

- 1.1 These terms and conditions for the **yourtown Bonus Draws in Draw 532** form part of the General Terms and Conditions for **yourtown** Prize Home Draw 532 <u>https://yourtownprizehomes.com.au/terms-and-conditions</u> Entry into these draws detailed in these terms and conditions is deemed acceptance of these Terms and Conditions entrants warrant that they are not prohibited from accepting a prize.
- 1.2 The **Bonus draws** are a Trade Promotion licence no ACT **TP23/02038** within the **yourtown** Prize Home Art Union Draw 532 under the following permit number ACT R23/00180.

- 1.7 Unclaimed Prizes in ACT If a prize is unclaimed in the ACT within 3 months of the draw date, **yourtown** will comply with the terms and conditions stipulated by ACT Gaming and Racing Commission in relation to a redraw. 2.0 Bonus Draws
