

Terms and Conditions for **myplace Four Draw Jackpot -** **Draw 551 – Draw 554**

1.0 General

- 1.1 These terms and conditions for the **myplace Four Draw Jackpot** form part of the **myplace General Terms and Conditions** in addition to the General Terms and Conditions for yourtown Prize Home Draws 551 – 554.

- 1.2 Entry into these draws detailed in these terms and conditions is deemed acceptance of these Terms and entrants warrant that they are not prohibited from accepting a prize.
- 1.2 The **myplace Four Draw Jackpot** is a Trade Promotion licence no ACT TP25/01932 within the yourtown Prize Home Art Union Draw 551 under the following permit numbers Qld Licence 29586, ACT R25/00161, NSW Licence GOCAU/2322, VIC Permit 10341/25, SA Licence M14842.
- 1.3 These Art Unions are run by yourtown ABN 11 102 379 386 of 5 Cordova Street, Milton Qld 4064.
- 1.4 Subject to satisfaction of the eligibility criteria, entry into the Myplace Four Draw Jackpot will be automatic for supporters who hold a yourtown myplace membership for the listed draw in Section 2.1.4.
- 1.5 The **myplace Four Draw Jackpot** will be drawn by electronic draw at 6am AEST at yourtown, 5 Cordova Street, Milton Qld 4064 on the stipulated dates listed in Section 2.1.10.
- 1.6 Winners will be announced on the day of each draw and published on the yourtown website at yourtownprizehomes.com.au/winners. Winners will be notified via phone and in writing by email and post (where applicable) on the day of the draw.
- 1.7 Unclaimed Prizes in ACT/NSW - If a prize is unclaimed in the ACT or NSW within 3 months of the draw date, **yourtown** will comply with the terms and conditions stipulated by ACT Gaming and Racing Commission in relation to a redraw. Such redraw for **yourtown** myplace Four Draw Jackpot 551 would occur at **yourtown**, Suite 5, Cordova St, Milton Qld 4064 on Monday, 8 June 2026 commencing at **6.00am AEST**. Note: "ACT" refers to the ACT address listed on the ticket of the purchaser.
- 1.8 Unclaimed Prizes in other States (excluding ACT and NSW)
Unclaimed prizes will be dealt in accordance with the combined legislative requirements for the conduct of the Draw. In the event that any bonus draws above \$5,000 in value remain unclaimed for one year following their draw dates, these will be redrawn on Monday, 8 March 2027 at 6.00am by electronic draw at yourtown Head Office, 5 Cordova Street Milton Qld 4064. Any prizes won by Entrants excluding NSW and ACT residents under \$5,000 in

value that have not been claimed within twelve months of the listed Draw Date will be sold and the proceeds applied to yourtown's charity purposes.

- 1.9 Entries are open to Australian residents who are 18 years of age or older, but excludes Members of the yourtown Board of Directors, Executive Management, any persons engaged in the draw process, all yourtown Information and Technology staff, and the immediate family of those detailed, are not eligible to enter. Overseas non-Australian citizens or residents must check in their own country that there are no restrictions on them purchasing a ticket in the draw or accepting the prizes offered as part of the lottery.
- 1.10 Where a prize is or includes Gold Bullion, Gold is valued at the purchase price on the day of the draw. Selling costs of between 2 and 2.5% apply and are incurred by the winner at the time of sale. The value of the Gold Bullion could be affected by the fluctuating spot price on the day of sale. The true value of the gold if sold may not be worth the full prize value as purchased on the day of the draw.
- 1.11 Prize values refer to Australian currency. All non-cash prizes are not redeemable for cash and no prize is transferable

2.0 Member Draws

2.1 myplace Four Draw Jackpot

- 2.1.1 Eligibility requires a customer to sign up (online or by phone) to become a myplace member during the campaign period in Draw 551 and continue as a myplace member until the closure of the campaign period in Draw 554.
- 2.1.2 The campaign period commences at 8.00am Qld time on Wednesday, 17 September 2025 in Draw 551 and expires at 10.00pm Qld time on Wednesday, 4 March 2026 in Draw 554.
- 2.1.3 Each myplace ticket purchased during the campaign period equals one chance to win the myplace Four Draw Jackpot prize.
- 2.1.4 Only new customers who join myplace in Draw 551 are eligible to win. Existing active and financial myplace customers are ineligible to win the myplace Four Draw Jackpot unless they are rejoining in this campaign due to lapsed or previously cancelled membership.

- 2.1.8 ‡Customers who purchase directly from Oz Lotteries website are ineligible to win this prize and must sign up directly with yourtown as a member to be eligible.
- 2.1.9 New customers who sign up as a myplace customer in Draws 551 – 554 to win the **myplace Four Draw Jackpot** will automatically be directly debited for their myplace membership into future draws until such time as cancellation is requested by the customer.
